3. HOLD HARMLESS

This application is for a permit to share Dunes City’s water right. The permit authorizes the permittee to extract water from Lake Woahink for uses consistent with a “domestic water right expanded,” as defined by Oregon Administrative Rule 690–300–0010(14)&(15). An expanded domestic water right allows the use of water for human consumption, household purposes, domestic animal consumption that is ancillary to residential use of property, related residential accessory uses and for the watering of up to one-half acre of lawn or noncommercial garden.

In consideration for the use of Dunes City’s domestic water right, the applicant community water system shall defend, indemnify and hold harmless, jointly with other permittees, or severably from other permittees, the City and its officers, employees, agents and representatives from and against any and all claims of injury, damage, loss and expense, including reasonable attorney’s fees, at trial and on appeal, and costs of suit, arising out of or resulting from negligent or willful misconduct associated with the issuance of the permit, including but not limited to the placement and monitoring of the water meter.

4. AGREEMENTS

By my signature below I confirm that I have authority to represent the community water system and that all further references to “I” are references to the community water system as a separate legal entity:

1. I am asking to use water specifically for domestic purposes only.
2. Evaluation of this application will be based on information provided in the application packet.
3. If the community water system is authorized to utilize water under Dunes City's water right, it must not waste water.
4. This water right is only available to serve structures located within the corporate limits of Dunes City.
5. If use of the water is not according to State and Local standards, the permit may be cancelled.
6. The community water system is in compliance with ORS 199.464(4)&(5).
7. The water use must be compatible with local comprehensive land use plans and other applicable laws. I assume all responsibility for compliance with such laws..
8. Even if Dunes City allows the community water system to utilize Dunes City's water right, Dunes City retains the right to rescind any and all rights granted to the community water system to utilize Dunes City's water right for violation of this permit.
9. If the application fee and annual administrative fees, or any fees associated with the use of Dunes City's water right, are not paid, the water use permit may be cancelled. You will be mailed a notice of cancellation ten (10) days prior to such action.
10. I agree to allow a Dunes City representative onto necessary properties, including property subject to an easement allowing diversion and/or transport across such property for property of the community water system in order to:
 - Install and/or replace a water meter
 - Conduct monthly readings of the water meter

- 11. I agree that only one point of diversion for the community water system will utilize the water use permit. This permit must be amended to allow for additional structures to be served by the community water system.
- 12. I agree that it is the responsibility of the community water system to maintain the water meter.
- 13. I agree that the permit to use Dunes City's water right is not a guarantee of the amount or quality of the water available for me/us. I understand that the permit only allows withdrawal of water from a natural body of water, not a water system developed by Dunes City, and it is subject to local claims of priority and natural fluctuation in quality and volume, outside the control of Dunes City.

By the signature below, I swear that all information provided in this application is true and correct to the best of my knowledge and that I have read, understood, and the applicant community water system agrees to abide with the requirements of this permit. I further certify that I have specific authority to respond to the questions set forth above and to act on behalf of the community water system, including the authority to make legal commitments.
